NARRATIVE

22-271024

On 11/12/2022 at 1910 hours I, Deputy Gaiter, made contact with a subject at 3435 Wrightsboro Road in reference to trespassing. I was working Special Duty at the listed location and I observed Nobie White put out a chair in front of one of the business. I asked Ms. White to move from where she was sitting. Ms. White did not have any business that she was conducting at the plaza. I asked her to leave and she refused. Ms. White said not to touch her. When she refused to leave I asked dispatch for an additional unit. I also observed Terrance McGhee at the same location he plugged in a bluetooth speaker and he was drinking liquor. I asked him to leave as well and he and Ms. White began arguing with me. Ms. White walked towards my patrol vehicle and said that she was going to complain. Ms. White walked back to in front of one of the vacant businesses on the property and she stood there and her and Mr. McGhee were taking there time leaving.

Deputy Lucree walked up and I advised Ms. White that she was under arrest. Ms. White refused to comply to put her hands behind her back and she said no. I felt her tense her right arm and I was able to place her on the ground. Ms. White tried to pull away and myself and Deputy Lucree took her into custody.

Mr. McGhee was issued a citation for trespassing. Due to Ms. White's combative behavior I committed her to the CBWDC. The incident was captured on BWC. Warrants will be signed on the accused.
