NARRATIVE

22-278247

On 11/22/2022 at 1949 hours I, Deputy Gaiter, conducted a traffic stop on the listed vehicle (2005 Ford Focus silver in color GA Tag#XAA936Z) on the 2900 block of Washington Road. The listed vehicle was traveling west on Washington Road and made a left turn in front a vehicle that was traveling east on Washington Road and almost caused a traffic accident.

I heard the tires screeching as the driver of the listed vehicle turned left onto oncoming traffic. I conducted a traffic stop after observing the traffic violation on the 200 block of Boy Scout Road.

I made contact with the driver Christopher Missimer and advised him why I stopped him. I could smell the odor of raw marijuana coming from the vehicle. I asked Mr. Missimer if there was any marijuana in the vehicle and he paused for a moment. Mr. Missimer attempted to reach into his the right front pocket of hi pants and hand me a plastic bag containing a small quantity of marijuana. Mr. Missimer asked for a warning because he stated that he was being honest. Deputy Morton and I advised Mr. Missimer to step out of the vehicle. Upon Mr. Missimer exiting the vehicle I observed a clear plastic bag under the front driver seat in plain view. I picked up the plastic bag and it contained mushrooms.

Deputy Morton began patting down Mr. Missimer and located a loaded firearm (Sig Sauer P365 black in color serial number #66B788080) in the left side of his waistband. Mr. Missimer was placed in handcuffs and in the back seat of my vehicle.

Deputy Morton located a black and blue backpack that contained two mason jars behind the front passenger seat on the rear seat. Both mason jars were filed to the top with lose marijuana.

I field tested the marijuana located in Mr. Missimer's pocket and the approximate weight was 5 grams.

The marijuana in the mason jars weighed approx 85 grams and the other weighed approx 65 grams.

I field tested the mushrooms and they tested positive. The marijuana and mushrooms were filed under property receipt #514952. The firearm was filed under property receipt #514928.
