Incident Summary

On 3/1/19 at approximately 2136 hrs, officers were investigating a suspicious vehicle parked in middle of the road, with no headlights, blocking the alley, in the rear of 3416 Hale Ave. Pursuant to the investigation, officers attempted to get the operator of the vehicle's information. Officers had operator sit in the driver's seat of the vehicle to await further instruction Operator then began going through a diaper bag in the front seat of the car. Officers instructed subject to not go through bags while in the car. Subject did not comply with officers demands to stop and suspect became very erratic. Officer's, fearing for their safety, not knowing what, if any possible weapons could be stored inside the car, decided to remove suspect from the vehicle and attempt to detain her. Suspect continually resisted officers attempts to place her in custody, at which point suspect began flailing her arms about and refusing to be handcuffed. To protect suspect and officers, Officers performed an empty hand, controlled take down on the suspect in order to gain control of her. During the takedown subject received abrasions to the right side of her face. Officer Straman applied pressure to the head/neck area of the subject while on the ground I spoke with Officer Straman and the rest of the squad about the proper way to control a subject with a knee, to avoid placing a knee on a head or back of a subject for an extended amount of time. Proper placement would be on the back between the shoulder blades Family of suspect stated that suspect has a history of schizophrenia, and had recently had a C section. Officers believing that suspect was potentially a danger to herself based on multiple factors, had her transported to UofL Hospital for an involuntary hospitalization. Suspect also charged with Obstructing a Highway, Resisting Arrest, and Obstructing Governmental Operations.

EMS Unit 274A transported the subject to University of Louisville Hospital for an involuntary hospitalization EMS Run #E19019845






