Good day,

I am filing a complaint and making a request. Let's deal with the request first

Related to an incident at on 9.15.24 at around 12 pm or so police were dispatched to my residence over a domestic dispute.

I am requesting the body cam of SGT Hall, Officer Garabaldi badge 164 and the cop in the image attached The CAD sheet from the call

The use of force report as badge 164 grabbed my son aggressively when he didn't like my speech .It was a retaliatory strike on me filming and talking to my son, if your cops can't stay focused on their job then fire them! If he did not file a use of force I want to know why. Force was used on my son.

Now on to the complaint, I will attach the video proof and you can view the body can also as I asked every single one of them if their body cam was on and they stated yes.

In regards to the officer in the image below. I told my son to shut up or they will beat him, I have the bicycle guy incident that shows how your agency rolls. I was concerned as badge 164 aggressively grabbed my son and they handcuffed him and forced him to the ground. They also threatened to tase my son for speaking, again, let me remind you there are protections for the first amendment under the freedom of speech and my son was not being arrested. They did a fake investigation and took the word of his girlfriend that he said something a week ago. This cop threatens to arrest me because he stated I said I was going to beat people up, he lied on camera, I never said that, I attached the video clips

The complaint is on Garabaldi badge 164 and the cop in the attached image, he left and went into hiding so I could not get his name.

These officers were unprofessional and clearly have contempt for the public. Threatened to arrest me based on a lie this cop attached made up on the spot. That's retaliation on the first. He made furer statements aimed at me recording that shows his disdain for being filmed. He was also pissed off I didn't go back inside as he directed me to, which proves further he does not want to be filmed.

So to be clear, I want the body cam from Hall. Garabaldi badge 164 and the cop attached. There is no victim to redact, they baker acted my son in retaliation for me filming, the 2nd time your cops have pulled this nonsense.



There is a LOT of footage on this incident. I am asking this to be sent to IA to review.
